OLD BUSINESS	Library Street Reconstruction Parking Configuration: The

**OLD BUSINESS** 

<u>Library Street Reconstruction - Parking Configuration</u>: The City Manager reported that the Ionia County Board of Commissioners has opened bids on the Court House addition project and plans to award bids at its March 14, 2017 meeting. Additionally, he reported that the City Council, at its March 7, 2017 meeting, accepted a bid for the reconstruction of Library Street along with Rich Street (Main Street to Lafayette Street) and Washington Street (Kidd Street to Jefferson Street). Considering this, he requested that the Planning Commission take action to recommend to City Council its preferred option of parking along the east side of Library Street (parallel v. angled). He reminded the Commission that the Library Board of Trustees has officially requested that the parking arrangement post street reconstruction be angled along the east side of the street in order to maximize the number of parking spaces available for library patron use.

Commissioners re-reviewed the two parking configurations prepared by the City's project engineers, Prein & Newhof and discussed the pros and cons of each configuration.

After discussion it was moved by Commissioner Hoppough, seconded by Commissioner Young, to recommend to the City Council that Option 1A entitled "Library Street Parking Concept" which includes making Library Street "one-way" (traffic traveling south from Washington Street to Main Street) and constructing angled parking along the east side of Library Street be approved. MOTION CARRIED.

<u>Updates to the Zoning Ordinance – Medical Marihuana</u>: The draft ordinance amendment has not yet been received from the City's attorney working on this matter.

COMMISSIONER COMMENTS Commissioners received updates regarding the pending demolition of 326 North Dexter Street and the City's 2017 street reconstruction projects.
