Ordinance No. 568 – Amend Section 1242.99 “Penalty” of Chapter 1242 – Administration, Enforcement and Penalty– of Title Six: Zoning – of Part Twelve: Planning and Zoning Code and Ordinance No. 569 – Amend Section 202.99 “General Code Penalty; Civil Infractions; Equitable Remedies; Complicity” of Chapter 202 – Codified Ordinances - of Title Two General Provisions – of Part Two: Administrative Code of the Codified Ordinances of the City of Ionia, Michigan

NOTICE IS HEREBY GIVEN that a Public Hearing will be held in the Council Chambers, Ionia City Hall, 114 N. Kidd Street, Ionia, Michigan on Tuesday, December 6, 2022 at 7:00 PM at a Meeting of the City Council, to receive comments on Ordinance No. 568 and Ordinance No. 569. If approved, these ordinances will amend Section 1242.99 “Penalty” of Chapter 1242 – Administration, Enforcement and Penalty to update penalties associated with zoning violations and amend Section 202.99 “General Code Penalty; Civil Infractions; Equitable Remedies; Complicity” of Chapter 202 – Codified Ordinances to clarify municipal civil infractions.

The following is a summary of the proposed ordinances.

AN ORDINANCE TO AMEND PART TWO, TITLE TWO, CHAPTER 202, SECTION 202.99 ENTITLED “ADMINISTRATION CODE; GENERAL PROVISIONS; CODIFIED ORDINANCES; GENERAL CODE PENALTY; CIVIL INFRACTIONS; EQUITABLE REMEDIES; COMPLICITY” OF THE CODIFIED ORDINANCES OF THE CITY OF IONIA

Ordinance No. 569:

Section One: Amendment to 202.99 “General Code Penalty; Civil Infractions; Equitable Remedies; Complicity”

Section Two: Repealer

Section Three: Publication and Effective Date

Following the public hearing the City Council will be asked to approve Ordinance No. 568 and Ordinance No. 569 on second reading. The ordinances will become effective seven (7) days after publication.
